- The UN High Commissioner for Human Rights, Zeid Ra'ad Al Hussein has announced that he will be stepping down from his post. In his [Annual Report and Oral Update to the UN Human Rights Council](#) he outlined the many critical human rights situations around the world. He stressed the humanitarian catastrophes in Syria, Yemen and Myanmar and included his concerns about the situation in Fiji, Papua New Guinea and West Papua. In February he gave [this speech](#) in Jakarta to mark the 25<sup>th</sup> Anniversary of the Vienna Declaration and 70<sup>th</sup> Anniversary of the adoption of the UDHR
